- 8.5 Bidders are responsible for ensuring that they have sufficient funds available to cover their bid(s).

- 8.7 If a Bidder's bid is the highest bid on an Item at the end of an Auction, [and is



above the Seller's reserve price,] that bid shall be deemed to have been accepted by the Seller, creating a legally binding contract between the Bidder and the Seller under which the Bidder is obliged to purchase the Item at the price of their winning bid and the Seller is obliged to sell the Item for the same.

- 8.8 All Bidders and Sellers shall be entitled to enforce the provisions of these Terms and Conditions and may pursue legal remedies against one another for non-performance of any of their respective obligations hereunder.
- 8.9 Payment for Items may be made by methods that will clearly be set out in the Notice to Purchasers for each lot.
- 8.10 Gavel Auctioneers Limited shall be under no obligation to release any Items to Bidders until they have received any and all sums due in cleared funds.
- 8.11 Gavel Auctioneers Limited transfer only legal title in and to Items shall transfer to Bidders only upon receipt of any and all sums due by Sellers.
